1. **Rules-** The Show will be held under the Licence and Rules of the Irish Kennel Club Ltd., as in force on the day of the publication of this schedule.
All Dogs must be registered with the Irish Kennel Club Ltd.
2. **Venue:** The Show will be held at The National Show Centre, Cloghran, Co. Dublin., on **Sunday 21st January , 2019**
3. **Entry Fees:** The Entry Fee will be €8.00 for First dog and €4.00 for each other dog or class Junior Handling Free if entered in Breed otherwise €3.00

All Stakes Classes €3.00 per dog.

6. **JUDGES:** In the event of any appointed Judge failing to keep his or her appointment, the committee reserves the right to appoint another Judge or Judges.
7. **Judging:** (1) The judging will commence at **11 00 am.** No claim will be considered in the event of an exhibit being late. (2) No persons will be allowed in the Judging Ring except the Judge, Show Officials, or an exhibitor taking in a dog for adjudication. (3) The exhibition number of each dog must be clearly displayed by his handler who shall not wear badge or other decoration in the judging ring. (4) Under no circumstances may the order of judging as provided for in the Catalogue be departed from.
9. **CATALOGUES** - The Promoting Body shall not be responsible for any loss, direct or indirect, occasioned by any mistake or omission in the Catalogue. In any such case the exhibitor should immediately inform the ring steward, if the judging is in progress, otherwise the exhibitor should immediately report the Catalogue inaccuracy at the Secretary's Office. Catalogues will be on sale price €2.00.

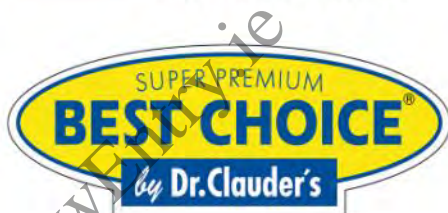
