I HEREBY UNDERTAKE not to bring within the precincts of the show any dog which has (a) distemper or other communicable disease, unless it has been fully recovered for more than 30 days immediately prior to the show or (b) has been in contact with or in any kennel or establishment containing distemper or any other communicable disease during 30 days immediately prior to the show.
4. IN CONSIDERATION of my entry being accepted, I hereby agree (1) to indemnify the I.K.C. Ltd. and /or its trustees or officials in respect of any damage or loss from whatsoever source arising, caused by, or to any dogs exhibited by me while in the precincts of the show and (2) that any decision given concerning me by the I.K.C. Ltd. or by any committee thereof in connection with any matter whatsoever arising through or at this show shall be communicated by the secretary of the I.K.C. Ltd. to all whom it may concern, and that any such decision together with a report of the proceedings in the matter may also be published together with my name, address and description.
5. I HEREBY UNDERTAKE to abide by the rules and regulations of the I.K.C. Ltd. and of its' show.
6. I UNDERTAKE to indemnify the promoters against any claims arising out of my participation as a competitor in the show.
