#### **SHOW REGULATIONS**

- **1. Jurisdiction:** The Show will be held under the Licence and Rules of the Irish Kennel Club Ltd., as in force on the 9<sup>th</sup> of November 2025.
- 2. Registrations: All dogs entered for pedigree dog competition must be registered or transferred at

the Irish Kennel Club Ltd.

**3. Venue:** The Show will be held in <u>Riverstick Community Centre</u>, <u>Riverstick Co Cork</u> P43 DX99.

Catalogues:. Will be on sale within the grounds price  $\in 3.00$ .

Car Parking is free to all exhibitors.

- 4. Entries: Service charge of €10 for 1<sup>st</sup> dog/1<sup>st</sup> class, €5 for subsequent dogs & variety classes. An exhibitor can enter as many dogs and classes as they wish for €30 All dogs must be owned by the same exhibitor.
- 5. Rosettes for all classes.
- 6. Entries will be received online up to midnight 1st November 2025.
- **7. Rejection of Entries:** The promoting body reserve the right to refuse any entry.
- **8. Entry forms, mistakes in:** The Catalogue will be compiled from the Entry Forms submitted by the Exhibitors, and while every endeavour will be made to have the Forms correctly interpreted, Fermoy Canine Club cannot accept any responsibility for mistakes which may bring Exhibitors within the purview of the Irish Kennel Club Ltd Rule 15, Sect. 1, or clerical mistakes that may occur during the compilation.
- **9. Ineligible Entries:** A transfer of an incorrect entry as to the sex or breed is allowed if reported to the secretary's office prior to the commencing of judging. A dog entered in a class for which it is not eligible may be transferred to the open class in that breed, but in no other respects.
- **10. Exhibits:** Each exhibitor shall be responsible for keeping their exhibits under proper control at all times.
- **11. Judges:** In the event of the appointed Judge failing to keep his or her engagement the Committee shall have the right to appoint another Judge or Judges.
- **12. Judging:** (a) Will commence at <u>1pm sharp.</u> No claim will be considered in the event of an exhibit being late, (b) No persons will be allowed in the Judging Ring except the Judge, Show Officials, or an exhibitor taking in a dog for adjudication. (c) The exhibition number of each dog must be clearly displayed by the handler, who shall not wear a badge or other decoration in the Judging Ring; (d) The Club will not be responsible for the exhibition of any exhibit in the Ring.
- 13. The show grounds will be open from 12pm. This will be strictly enforced. Facilities will not be available prior to 12pm.
- **14. Interpretation:** The Committee of the Promoting Club shall be the "Show Committee" within the meaning of the I.K.C. Rules, all disputes, if any, shall be dealt with by the Committee. Parties to any dispute shall have the right to appeal to the Irish Kennel Club Ltd.
- **15. Accident or Damage:** The Club will not be responsible for any loss or damage sustained through accident by exhibits, exhibitors or other persons attending the Show.

#### **CLASS DEFINITIONS**

**Baby Puppy Class** is confined to puppies of four months of age and under six months of age on the first day of the show. Baby Puppies are confined to this class and may not compete for any other award other than Best Baby Puppy in Show

**Puppy Class** is confined to dogs over 6 and under 12 months of age on the day of the Show **Junior Class** is confined to dogs over 9 and under 18 months of age on the day of the Show.

An Intermediate Class is for dogs between 15 and 24 calendar months of age on the first day of the Show.

Open Class is confined to dog over 15 months on the day of the Show.

A Champion Class is for dogs who have gained the Title of Champion under Irish Kennel Club Rules or under a recognised Kennel Authority confirmed by the date of closing of entries and <u>may not compete for</u> any other award other than Best Champion in Show & Champion Stakes.

#### **Neuter Class:**

The classes can be offered at all Championship & Open Shows in the breed and the Best Neuter Male and Best Neuter Female can compete for Best Neuter in Breed and go forward to Best Neuter in Show, BUT they do not compete for the Green Stars and there is no Neuter Champion title.
