SHOW REGULATIONS

1. The Show will be held under the rules of The Irish Kennel Club Ltd, as in force on the date of the publication of the schedule and will be on display in an abridged form on the day of the show.
The Show will be held at Down Royal Racecourse, Gravelhill Road, Lisburn, BT27 5RW
2. Entry Fees:

First Dog	€27/£27
Additional Dog(s) by same owner	€10/£10
Baby Puppies	€8/£8
Dogs not for Competition	€5/£5
3. Catalogue: Free online Catalogue
4. Dogs registered in partnership or joint owners are treated as separate entries, even when forwarded by single owners. In the event of insufficient information on the entry form an administration fee of €6/ £6 will be automatic in the case of entry fees, in addition there will be a €4 charge plus bank exchange rate charges.
5. Entries will be received up to and including 22nd May 2026 by the secretary, MRS JANE ANTHONY, 140 WATERLOO GDS, LARNE, BT40 1EU.

The Hungarian Vizsla Club of Ireland will accept no responsibility for mistakes in the show catalogue which may bring exhibitors within the purview of the Irish Kennel Club rules.
5. Prize cards will be given to 1st 2nd 3rd and Reserve. Rosettes will be given to Green Star, Best of Breed, Best Puppy in Breed, Best Baby Puppy in Breed, Best Veteran in Breed, Group Winners, Reserve Group winners, Best in Show and Reserve Best in Show.
6. The Entry fee of exhibits failing to arrive or rejected by the veterinary surgeon will be forfeited.
A veterinary surgeon, or an authorised substitute, in attendance will have power to exclude any exhibit which in his/her opinion is not in a fit state for exhibition on account of disease, vice or any other cause.
Judging: (a) Will commence not before 11 am. No claim will be considered in the event of an exhibit being late
(b) No persons will be allowed in the Judging Ring except the Judge, Show Officials, or an exhibitor taking in a dog for adjudication. (c) The exhibition number of each dog must be clearly displayed by the handler, who shall not wear a badge or other decoration in the Judging Ring; (d) The Club will not be responsible for the exhibition of any exhibit in the Ring.
7. In the event of a Judge failing to keep his/her engagement, the committee reserves the right to appoint another judge(s).
8. Interpretation: The Committee of the Hungarian Vizsla Club of Ireland within the meaning of the I.K.C. Rules, all disputes, if any, shall be dealt with by the Committee. Parties to any dispute shall have the right to appeal to the Irish Kennel Club Ltd.
9. Ineligible Entries: A transfer of an incorrect entry as to the sex or breed is allowed if reported to the secretary's office prior to the commencing of judging. A dog entered in a class for which it is not eligible may be transferred to the open class in that breed, but in no other respects.
10. The Hungarian Vizsla Club of Ireland will not be responsible for any loss, damage or accident to any person, property or dog in the show or attending same.

12. All exhibits must be kept on a lead at all times.

Re: Registration of Dogs Entered

Addition to above Rule:

Failure to comply with the above will result in:

The Dog being disqualified from the event and

The exhibitor being fined €130.00

The implementation of which shall be a Normal (I.K.C.) Office routine

PLEASE ENSURE THAT YOUR DOG IS REGISTERED CORRECTLY BEFORE THE DAY OF THE SHOW,
AND WHERE POSSIBLE ENSURE TO FILL IN THE REGISTRATION ON THE ENTRY FORM.

9. *Puppies under the age of 6 months should not be present on the show grounds unless being exhibited where a baby puppy class is scheduled.*

10. *Exercise/Puppy Pens: are prohibited within the confines of the exhibition area at all shows licensed by the Irish Kennel Club.*

Ring Numbers can be downloaded

All aisles between rings are to be kept clear of cages and grooming tables.

Videos

It is a Kennel Club regulation that permission must be sought from the show promoting body for the use of video or other recording equipment. Permission must also be obtained from the judge in the ring on the day.

CLASSIFICATION FOR ALL BREEDS WHERE APPLICABLE

Dogs: Baby Puppy, Puppy, Junior, Intermediate, Adult, Open, Champion, F/Trial.

Bitches: Baby Puppy, Puppy, Junior, Intermediate, Adult, Open, Champion, F/Trial.

Please Note - All Breeds will have Field Trial Dog and Bitch classes.

Baby Puppy Class [is confined](#) to puppies of four months of age and under six months of age on the first day of the show. Baby Puppies [are confined](#) to this class and may not compete for any other award

Puppy Class [is confined](#) to dogs over six and under twelve calendar months of age on the first day of the Show.

Junior Class is for dogs between 9 and 18 calendar months of age on the first day of the Show.

Intermediate Class is for dogs between 15 and 24 calendar months of age on the first day of the Show.

Adult Class is for dogs between 24 and 36 calendar months of age on the first day of the Show.

Open Class is for dogs over 15 months of age on the first day of the Show.

Champions Class is for dogs who have gained the Title of Champion under Irish Kennel Club Rules or under a recognised Kennel Authority confirmed by the date of closing of [entries](#).*** A Veteran Class is for dogs over eight years of age on the first day of the Show.

FIELD TRIAL CLASS [is confined](#) to dogs that have won at least a reserve in a Novice, Puppy, [Derby](#) or Open Stake.

Please Note: A Veteran [Dog who is a Champion](#) may enter in either Veteran or Champion Class but not both.

N.B.: A Dog or Bitch may [be entered](#) in **ONE BREED CLASS ONLY** (No double entries)

Cropped Dogs

Cropped dogs are not [permitted](#) to [be exhibited](#) at any Irish Kennel Club licensed event.
